**Preamble**

This document outlines the aims and objective of an executive body to take necessary steps for building an official Aga Khan School Dhaka Alumni Association [hereinafter referred to as AKSDAA].

AND

Organizing reunions and alumni activities till the association is formed. This will be the official authorized committee to initiate and execute the implementation of the formation of the AKSDAA (Aga Khan School Dhaka Alumni Association)

Once a draft of the constitution has been charted for the alumni association, the draft will be shared publicly with AKS, D Alumni members to provide their feedback. The executive body responsible for creating the association is not the association itself. A formal structure of how the association will be formed will be drafted in the article and once agreed upon, executed.

Things to consider will be:

- How many people will comprise the board of the association
- Who can be a part of it
- How the board will run
- How the association will fund itself

At the moment, to get the ball rolling, any student may contribute for covering expenses of registering the association and forming this body. All contributions and expenses will have transparent records for anyone to see and how it is being used. No binding financial commitment from either entity is to be imposed at this stage.

This document outlines the vision and mission of the executive committee and how the association will be formed. This body will work with a 2/3<sup>rd</sup> majority voting, we will however always prefer unanimous voting. Anyone who wants to join will be brought on board through a voting by the EC members. The management structure of this body will be lateral with no hierarchy (see section V).

## **DEFINITIONS**

**AKS, D:** Aga Khan School, Dhaka

**AKSDAA:** AKS, D Alumni Association

**COMMUNITY:** The Aga Khan School Community inclusive of the teacher, student body, alumni and anyone associated directly with the Aga Khan School.

## **THE ASSOCIATION**

The official name of the association shall be “The Aga Khan School Alumni Association, Bangladesh”, hereinafter referred to as “the Association”. The name shall be abbreviated to “AKS, D Alumni Association” or “AKSDAA”

### **II. STRATEGIC OBJECTIVES**

The Alumni Association will represent a graduate alumni body that:

- II.01 Is supportive of the wellbeing and advancement of its members
- II.02 Will have a powerful voice in guiding the community’s strategic direction
- II.03 Values the diverse talents and viewpoints of each member of the community
- II.04 Keeps company with and supports one another
- II.05 Is not political and will work only for the overall benefit of AKSDAA & SOCIETY at large

### **III. STRATEGIC APPROACH**

We must adopt an approach that is:

- III.01 Prospective – recognizing that affinity for the AKS, D experience begins with the quality of the graduate student experience and enhances through lifelong learning and engagement
- III.02 Supportive - responding to and anticipating the needs and interests of graduate alumni which must guide our efforts in promoting their personal and professional development.

III.03 Comprehensive – supporting and developing the graduate alumni network requires the "Whole of AKS, D" working together, one that fully integrates the efforts of all Alumni worldwide.

III.04 Inclusive – our approach must also enliven and enrich the lives of graduate Alumni by reinforcing an atmosphere of fellowship among fellow Alumni.

#### **IV. AIMS, GOALS AND ACTIVITIES**

IV.01 Organize the alumni of The Aga Khan School Dhaka (hereinafter referred to as AKS, D) and advance the interests of the alumni and AKS, D

IV.02 To bring together the Alumni of the school with a view to working together for the good of the school and Alumni.

IV.03 Generally to facilitate interaction, acquaintance, and exchange of ideas amongst members of the Association for the common good of AKS, D.

IV.04 Promote and provide additional services and activities for the alumni all over the world

IV.05 Support the wellbeing and advancement of its members

IV.06 Have a powerful voice in guiding the community's strategic direction

IV.07 Remain apolitical and work only for the overall benefit of alumni

IV.08 To do all those things which are incidental to but not inconsistent with the above aims and objectives
